8.1 <i>'Combating the defamation of religions: a report of the Australian Human Rights and Equal Opportunity Commission to the United Nations High Commissioner for Human Rights'</i>	<p>A discussion about the paper and the statistics relating to persons identifying as no religion or non-stated was highlighted. It was noted that there is a difference between identifying as 'religious' or 'spiritual'. The diversity of beliefs was also recognised.</p> <p>Concern was raised around low attendance of minor religious groups represented on REAC. It was suggested that this may be due to irrelevance of REAC group, the volunteer nature of the work or understaffing in smaller organisations. It was suggested that REAC meet more than four times a year to 'workshop'. It was highlighted that meetings should be kept to a minimum and not to have meetings for meetings sake.</p>	Executive Officer to contact REAC members who have not attended regularly to encourage attendance at future meetings.
8.2 <i>Student Protection Training</i>	The Chair explained processes for student protection training. Student Protection Training requires an EQ ID. For this reason it is important that chaplains or religious instruction teachers approach the principal of the school who will decide if the chaplain or religious instruction teacher requires on-line training or fact sheets. Certificates are provided at the end of the on-line training.	Executive Officer to provide REAC members with a link to the student protection training fact sheets.
8.3 Employing Authority Application	The Assistant Director-General Student Services advised that the current application to become an employing authority of chaplains was currently being considered. Recommendations from the Advisory Committee for employing authorities of chaplains (ACEA) have been acknowledged and further information was requested from the applicant.
